ESTIMATING CASES FOR COVID-19 IN SOUTH AFRICA: UPDATED 19 MAY 2020

The South African COVID-19 Modelling Consortium have noted some uncertainty regarding both the true scale and spatial distribution as a result of PUI criteria and testing coverage. The models developed by MASHA, SACEMA and HE2RO in conjunction with the NICD have been considered. There has been extensive and ongoing input from clinicians, virologists, intensivists and epidemiologists to refine key model assumptions and parameters.

This estimates requirement for PPE, ICU beds and Staff, Ventilators, Testing, O2, hospital beds, medications and PHC staff. Under almost all scenarios hospital and ICU capacity will be exceeded, though the timing and extent are uncertain. This requires a flexible approach to resource acquisition with initial purchases now and additional orders as more information becomes available.

Martin Kingston from Business for South Africa was interviewed on Bruce Whitfield's Money Show on Radio 702 this week and called on the government to restore people's capacity to earn in order to avoid social collapse.

"We think that we're on the brink here - it's not a life versus livelihoods debate, it's about addressing the fundamental issues that underpin society where we can give people access to nutrition, where we can be assured that they can deal with health concerns. Loss of income is linked quite explicitly to lower life expectancy, therefore we need to return the economy to full productivity as soon as possible"

SECOND DRAFT DISASTER MANAGEMENT TAX RELIEF AND RELIEF ADMINISTRATION BILL

20 May 2020 Update: National Treasury and SARS publish the 2nd revised 2020 Draft Disaster Management Tax Relief Bill and revised Draft Notice on Expanding Access to Living Annuity Funds. These are published to provide early feedback on issues raised through public comment on the revised COVID-19 Draft Tax Bills published on 1 May 2020 that are time-critical for payroll and other aspects to be implemented in May 2020.

The 3rd revised 2020 Draft Disaster Management Tax Relief Bill and 2020 Draft Disaster Management Tax Relief Administration Bill, as well as the Notice on Expanding Access to Living Annuity Funds, **will be published by the end of May** to take into account all public comments received on the revised COVID-19 Draft Tax Bills published on 1 May 2020. They provide the necessary legislative amendments required to implement the tax measures to combat the COVID-19 pandemic.

NICD CLINICAL MANAGEMENT OF SUSPECTED OR CONFIRMED COVID-19 DISEASE - VERSION 4

The clinical spectrum of COVID-19 ranges from an asymptomatic or mild flu-like illness to severe pneumonia requiring critical care. These guidelines describe the clinical management of cases of COVID-19 disease, including clinical care in and outside of healthcare facilities, and are intended for use in both the public and private sectors.

The National Department of Health is committed to providing regular updates of guidelines, as knowledge regarding strategies to address COVID-19 develops both globally and in South Africa. This version of the guidelines provides updated and additional information on the diagnosis and management of patients with COVID-19, as well as specific guidance on the management of specific groups such as pregnant and breastfeeding women, children and people living with HIV.

What must I do to prepare my workplace and have staff return to work?

There are now Occupational Health & Safety Measures that all businesses, apart from health facilities and practices, must adhere to. This applies to those who have been supplying essential goods this far, as well as those that may partially re-open from level 4 and down.

Where can I get a list of goods that are banned from export by the government?

The restrictions on Personal Protective Equipment are set out in the published **Export Regulations**.

The regulation provides that items listed in schedules 1,2,3 and 4 shall not be exported from the Republic of South Africa except by virtue of an export permit issued in terms of Section 6 of the said International Trade Administration Act.2002.

COVID DEVELOPMENTS

TRACKING THE PANDEMIC



More than 40 000 people are expected to die from the coronavirus in South Africa by November, one million people will be infected and the country is unlikely to have enough ICU beds at the peak of the pandemic. Projections also show there would be 30 000 confirmed cases of Covid-19 in South Africa by the end of May with one million cases projected by June and July.

ECONOMY, POLITICS, ENVIRONMENT, EDUCATION, SOCIAL

Lockdown: Gauteng Premier David Makhura says the entire province will move to Level 3 of the lockdown at the beginning of June. The premier addressed previous updates of different parts of Gauteng being in different levels of lockdown.

The premier also told the provincial legislature that the <u>coronavirus has left the province with an "astronomical" challenge</u> on its hands and has exposed urban poverty in the country's economic hub. Describing the fallout from the Covid-19 outbreak, the premier said it compared to the great depression economically, which had the potential to destroy livelihoods, economies, investments of businesses, and the pensions of ordinary working people.

State owned entities have reported challenges of not being able to pay employees, the state-owned arms manufacturer, <u>Denel</u>, <u>has become the latest company to join a growing list</u> that are telling employees funds for salaries are falling short.

Reopening of schools: Food programme, transport will be available under safety protocols

The National Coronavirus Command Council and Cabinet have approved the reopening of schools as of 1 June, Basic Education Minister Angie Motshekga announced. The school reopening, will start with grades 7 and 12 as well as "small schools". The minister said independent or private schools would also be opening in the metropolitan areas, adding the revised school calendar would be gazetted soon.

The department said it would ensure that, by the time pupils return, it would have sanitised classrooms and that masks, sanitisers and other personal protective equipment (PPE) would have been delivered to schools. The School Nutrition Programme will be aligned with the phasing in approach, and measures were being put in place to ensure that those pupils returning from 1 June will be receiving food. The people handling the food will be provided with gloves, aprons and face cloths.

CLINICAL, SCIENCE

The Gauteng Department of Health has observed an increase in the number of <u>TB and HIV patients</u> <u>defaulting on medication</u> since the lockdown was implemented in March. According to the department, 1 090 patients failed to collect their TB medication and 10 950 failed to collect their antiretroviral medicines. As a result, the department is implementing a track-and-trace plan to locate patients who have not collected their treatment.

This will be achieved through ward-based outreach teams.
