DETERMINATION OF ALERT LEVELS AND HOTSPOTS

In the President's address, Ramaphosa indicated that South Africa would be moving to level 3 Nationally, but that certain hotspots have been identified. Areas which are hotspots could be adjusted to higher levels of lockdown, subject to specific criteria.

Hotspots include:

- Tshwane
- Johannesburg
- Ekurhuleni
- Ethekwini
- Nelson Mandela Bay
- Buffalo City
- Cape Town
- West Coast, Overberg and Cape Winelands
- · Chris Hanie district in the Eastern Cape, and
- iLembe District in KwaZulu-Natal

The regulations have been updated with Alert Level 3 in mind. Please note, there are still specific economic exclusions which can be found under table 2. There is also the addition of Form 6 which is for persons intending to travel to and from another province during alert level 3.

ORGANISATIONAL RESPONSIBILITIES TO VULNERABLE EMPLOYEES

Guidelines have been issued on **vulnerable employees**, i.e. those 60+, with co-morbidities, pregnant, etc. This gives the details on what is expected of employers, and healthcare professionals, in terms of regulation 5(5)(e) of the 29 April Regulations.

Important points are:

- Work from home for these groups is best as per the regs, but if not possible at all, then:
- A doctor's report is required (page 2, point 3) this takes the form of a notice to the employee and the doctor does NOT disclose the specific health circumstances if it falls within the list. If outside of the list, details would need to be provided, with the patient's consent.
- Special measures, BEYOND the normal (i.e. PPE, hygiene, etc.) must be taken, namely reasonable accommodation to a setting where exposure is eliminated, isolation, task changes, etc.

• Return to work policies must be in place (include in Annexure E plans)

HCPs are fearful that their assessment could lead to employees or even students/learners facing **negative repercussions**. However, no person may be discriminated against on their COVID-19, suspected COVID-19 status, and sick leave must be paid, and/or the TERS fund utilised for illness benefits (even if the employee is not sick), etc. The Employment Equity Act (EEA) would apply to prevent employment discrimination and the Promotion of Equality and Prevention of Unfair Discrimination Act (PEPUDA) to all non-employee situations.

Disclosures have also now become a much bigger issue. If a co-worker tests positive or becomes a PUI, e.g. a family member tested positive, disclosures to others with whom the person was in direct contact must be made. The person who tests positive and all direct contacts must be reported by the HCP to the NICD. The employer must include the issues of disclosure of positive and PUI employees, and third parties (e.g. customers/clients/patients) in its **Annexure E plan**.

REQUIREMENTS FOR THE MANUFACTURE, IMPORTATION & DISTRIBUTION OF RAPIDLY DEVELOPED INVASIVE & NON-INVASIVE VENTILATORS

In response to the anticipated shortage of medical supplies and equipment in the health care system as a result of the outbreak of the COVID-19 pandemic, the South African Health Products Regulatory Authority (SAHPRA) has drafted minimum requirements for the manufacture, importation and distribution of rapidly developed invasive and non-invasive ventilators.SAHPRA has added this new guidance on the rapidly developed ventilators to their <u>website</u>.

It covers the regulatory requirements, technical specifications, licence conditions and authorisation for use of unregistered rapidly developed invasive and non-invasive ventilators for COVID-19.

UPDATED JOINT COMMUNICATION WITH SABS & NRCS

To assist manufacturers during the COVID-19 crisis, the South African Bureau of Standards (SABS) in collaboration with the South African Health Products Regulatory Authority (SAHPRA), the National Regulator for Compulsory Specifications (NRCS), and the Department of Trade and Industry will provide support to manufacturers and distributors in respect of applicable standards and conformity assessments to assist them to prepare for the licensing and approval process. The joint communication between SAHPRA, SABS and the NRCS has been amended to include an annexure A clarifying regulatory requirements for face masks in light of COVID-19.

B4SA UPDATE: BUSINESS FOR SOUTH AFRICA PROVIDES UPDATE ON PPE PROCUREMENT

In March, Business for South Africa (B4SA) was set up as an independent and broad coalition of volunteer resources, made up of business organisations and large and small companies, to assist the country in its response to the pandemic. Its core executive sponsors are the Black Business Council and Business Unity South Africa.

As part of this coalition, B4SA established an independent, efficient and scalable procurement platform to urgently help secure the personal protective equipment (PPE) needed in South Africa. This is a critical function that is underpinned by a team of skilled and capable volunteers with a robust governance structure and enables buyers and donors of PPE to timeously access bulk orders of products which meet the necessary specifications, on a cost effective basis.

B4SA's PPE procurement platform is one of many initiatives that are assisting the country to procure critical PPE for frontline health care workers. All parties involved in B4SA operate on the premise that they do so on either a pro bono or not-for-profit basis.

MEDICAL GRADE MASKS TO BE USED FOR FRONTLINE HEALTH CARE WORKERS ONLY



Business for South Africa calls on all businesses and the public to heed Government's call to reserve ALL medicalgrade masks, including N95 respirators and medical surgical masks, for the exclusive use by frontline health care workers. Government has also recommended that members of the public and businesses wear cloth masks, and has provided guidelines for their manufacture and use.



The pandemic has exposed the global risk of an over-reliance on single markets for the supply of PPE. South Africa, as a historic net importer of PPE, is no different. At the onset of the pandemic, PPE represented less than 2% of the overall medical equipment sales in the country, with surgical gloves making up the vast majority of this. To compound this, South Africa, like much of the world, had limited internal manufacturing and supply capacity and capability to deliver the vast quantities of PPE needed in the country.

B4SA's order book is currently at R1.1 billion. This includes the procurement of:

- N95 respirators: 12 million
- Surgical masks for patients and health care workers: 38,2 million
- Gowns: 100 000
- Goggles/face visors: 120 000
- Gloves (pairs): 900 000
- Sanitizers: 275 000 litres
- Ventilators: 200

The forward looking procurement pipeline stands at R200 million and B4SA's procurement focus is on securing gloves, gowns, scrubs, sanitiser, face visors, biohazard bags and FFP2 masks.

REPORT UNLICENCED COMPANIES TO SAHPRA

Several members have contact SAMED about companies trading medical technologies without a SAHPRA Medical Device Establishment License. These companies are trading illegally and it is essential that they be reported to SAHPRA for investigation.

SAHPRA has published a list of licenced companies under documents on their <u>medical devices</u> <u>page</u> which you can use to check if the company has a Medical Device Establishment License before sending a report. COVID-19 EVENTS

CONFIDENTIALITY & COVID-19: EKA SNAP SESSION

EKA is again hosting one of its **Snap Sessions** in response to pertinent COVID-related issues on **28 May 2020**, **18:00** - **20:00** via Zoom.

The Disaster Management Regulations and the Notifiable Medical Conditions Regulations authorise the **collection**, **use and disclosure of personal information**, including health information and information on age and addresses.

Employers are expected to keep a list of employees 60 years and older, as well as all employees with comorbidities. Screening criteria are applied by health facilities and businesses to visitors, (prospective) patients, company representatives, etc. Tests are expected and results are to be disclosed in some cases. Vast amounts of personal information are collected, stored, used, and in, some cases, passed on to others. This raises important compliance questions.

As limitations to the right to privacy are constitutionally determined, **pertinent questions** will be addressed:

- Are these disclosures mandatory? Can someone refuse to provide this information?
- What can, or must, an employer or a business do with this information? To whom can it be disclosed, if at all?
- How can or should this information be used?
- Can the Department of Labour, the NDoH / NICD or third parties insist on accessing this information?
- How should businesses, practices and employers protect this information? Should it be destroyed and if so, at what stage?
- If an employee or visitor is being quarantined, should that fact be disclosed to protect others, or not?
