#### **AFRICAN MEDICAL SUPPLIES PLATFORM**

All 55 member states of the African Union (AU) are now able to place orders for certified coronavirus (COVID-19) critical medical equipment via an online one-stop shop.

Named the Africa Medical Supplies Platform (AMSP), the online portal was unveiled during a virtual media conference convened by president Cyril Ramaphosa, the current AU chairperson, on Thursday evening.

Ramaphosa described the portal as a jewel in the crown of Pan-African cooperation, noting that COVID-19 has provided a great opportunity as much as it is a dark cloud hanging over the continent. "The silver lining around it is the creativity that has surged to the fore, finding ways of solving a problem.

"The Africa Medical Supplies Platform, developed in partnership with Afreximbank, is a ground-breaking innovation. It is a continental online portal to enable every single African country to access critical medical supplies needed in the fight against the pandemic.

"Through this platform, we will address shortages and security of supply, ensure price competitiveness and transparency in procurement, reduce logistical delays, simplify payment processes and provide a common platform where governments can access services from quality and certified suppliers.

Think of it as the Amazon, the Alibaba or even the eBay of coronavirus resources on the African continent - made in Africa by Africans." Ramaphosa - Read more.

At a meeting last week, the UIF confirmed the following with respects to the COVID-19 TERS:

- 1. The Fund is committed to paying benefits for 3 months.
- 2. The Fund will honour the R40 billion committed to by the Department.
- 3. The benefit structure will not change.
- 4. The COVID-19 TERS will not continue beyond the end of June 2020.
- 5. June 2020 applications will be opened from midnight of 23 June 2020.
- 6. A media statement will be issued to communicate the cut-off dates for April, May and June applications.

#### WESTERN CAPE DEPARTMENT OF HEALTH BRIEFING

The Ad-hoc Committee on COVID-19 was briefed by the Head of the Western Cape Department of Health on its COVID-19 response strategy which was met with admiration and appreciation.

The presentation gave an encompassing view including its approach to contact tracing, critical and palliative care bed status, budget expenditure, National Department of Health support; private hospital

reserving test kits in short supply for high-risk people, health workers and the sick.

A breakdown was given of hospitalisation and bed numbers. Temporary hospitals had been set up at Cape Town International Convention Centre (CTICC) with 862 beds; CTICC 2 with 800 beds, Brakengate with 338 beds; Cape Winelands with 150 beds and Khayelitsha with 60 beds. National Department of Health (NDOH) support saw Minister Mkhize designating Dr Nicholas Crisp to assist the Western Cape Health team in the finalisation of plans to address the challenges with the primary task being to assist with the implementation of a hotspot containment. Hospitals are split between the private and public sector; with a Call for Service issued to all licensed private hospital groups in the Western Cape to purchase bed capacity for Palliative care, General and High Care and ICU.

The number of health worker infection cases was cumulatively at 1832; 652 were currently active while 15 had passed away. Risk 1 dealt with testing strategy and capacity; Risk 2 with recruiting and sourcing of additional staff members; Risk 3 dealt with budget approval and availability of finances.

Members of the COVID-19 Ad-hoc Committee asked, with the new testing regime policy that no under 55-year-olds may be tested for the virus, how would the Western Cape identify when it had entered its peak and what was being done about returning to normal? Was it true that community screening and testing was not a high priority? People living in disadvantaged communities do not have the space to self-isolate so what is WCDOH doing about that?

## ENS AFRICA: A NON-EXHAUSTIVE LIST OF RECENT MEASURES AIMED AT CURBING THE SPREAD OF COVID-19 IN AFRICA

- Africa: African hotel development had returned to growth at the start of 2020, with more than 78,000 rooms in 408 hotels in the pipeline, according to the 12th annual survey by W Hospitality Group. W Hospitality Group's managing director, Trevor Ward, said: "However, our industry has been devastated by the impact of COVID-19, possibly more so than most other economic sectors, mainly because of the almost total shutdown of borders and of the aviation sector no flights means no guests." This year's African Hotel Chain Development Pipeline survey covers 35 international and regional hotel contributors across the 54 countries in north and sub-Saharan Africa, and in the Indian Ocean islands. - Africa: The Africa Medical Supplies Platform (AMSP) adopted as a single online marketplace to
  enable the supply of COVID-19-related critical medical equipment in Africa was developed under
  the leadership of African Union Special Envoy, Strive Masiyiwa and powered by Janngo on behalf
  of the African Union's Africa Centres for Disease Control and Prevention (Africa CDC) and in

of vetted manufacturers and procurement strategic partners and enables African Union member states to purchase certified medical equipment such as diagnostic kits, personal protective equipment and clinical management devices with improved cost effectiveness and transparency. The platform serves as a unique interface enabling volume aggregation, quota management, payment facilitation as well as logistics and transportation to ensure equitable and efficient access to critical supplies for African governments. The Afreximbank will facilitate payments while logistics partners including African national carriers, global freight forwarders will expedite delivery. *Source: APO Group* 

- Arica: With the ongoing COVID-19 pandemic crippling economies the world over and set to trigger into motion Africa's first recession in 25 years, the United Nations Economic Commission for Africa (UNECA) and its partners teamed-up to produce a new report which proposes several interventions to promptly and effectively address COVID-19 challenges on the continent at the urban level. The report titled: 'COVID-19 in African Cities: Impacts, Responses and Policies', analyses the current situation within the African continent and efforts channeled at mitigating the global pandemic within the context of cities in the region. - Africa / China: To defeat COVID-19 through greater solidarity and cooperation, and to highlight an
  even stronger China-Africa community with a shared future, Chinese and African leaders
  convened an Extraordinary China-Africa Summit on Solidarity Against COVID-19 via video link on
  17 June 2020. The Summit is a joint initiative between the People's Republic of China, the
  Republic of South Africa in its capacity as the Chair of the African Union (AU), and the Republic of
  Senegal in its capacity as the Co-Chair of the Forum on China-Africa Cooperation
  (FOCAC). Source: tralac
- West Africa: West African government ministers have proposed re-opening borders between their countries in the first half of July and allowing in travellers from other countries with low or controlled levels of COVID-19 spread by the end of July. Countries across the 15-country ECOWAS trade bloc have imposed varying levels of travel restrictions in response to the COVID-19 pandemic, with many shutting their borders entirely. The new proposal, contained in an ECOWAS summary of a virtual meeting of foreign ministers and trade ministers, called for coordinated efforts to re-open cross-border trade that has been crippled by COVID-19 restrictions. - Ghana: The Ghana Revenue Authority (GRA) has directed its Customs Division at the port to
  resume normal operations, as their shift system which was put in place due to measures to check
  the spread of COVID-19 has been cancelled. The move is part of urgent steps being taken by the
  GRA to ensure that the backlog of goods that have not been cleared at the port, due to challenges
  faced with the newly introduced Integrated Customs Management System (ICUMS) managed by
  UNIPASS, is handled quickly. Source: GhanaWeb
- Kenya: Efforts to speed up cargo movement in the region received a major boost on Tuesday, 16 June after the European Union (EU) signed a deal with Trademark East Africa (TMEA) to fund safe clearance at the ports and border points. Under the KES602-million (EUR5-million) emergency trade programme, mobile testing labs will be provided at Mombasa port and key border crossings, including Busia and Malaba. The programme to be rolled out under public-private partnership will also provide personal protective equipment to port and border point workers to cushion them from COVID-19 spreading at these trade hubs. - Kenya: Kenya Power and Lightning company has issued a profit warning for its financial earnings
  closing on 30 June 2020, saying its earnings will be much lower than those of the previous year.
  The electricity distributor has attributed the projection to the COVID-19 pandemic, saying it has
  adversely affected business operations leading to slow growth in electricity sales. Additionally, the
  virus has led to an increase in financing costs, resulting in reduced earnings. Source: Capital FM
- **Kenya:** The government is betting that its spending running into a total of KES3.2-trillion in the fiscal year starting 1 July will be enough to keep the economy from falling into a recession by countering the contractionary impact of the COVID-19 pandemic. The National Treasury projects that GDP will grow at a slower 2.5% in the upcoming financial year and thereafter rebound to 5.8% in the subsequent year. *Source: Business Daily*
- **Kenya:** The government has bowed to pressure from the International Monetary Fund (IMF) and agreed to do away with income tax, value-added tax and sales levy cuts that were introduced during the COVID-19 pandemic. Treasury Secretary Ukur Yatani told Parliament that once the COVID-19 pandemic ends, the government will have to review the tax breaks so as to close the gap between the budget and expected revenues estimated at KES840-billion. *Source: Business Daily*
- Malawi: The Ministry of Transport and Public Works has recommended that the country's airports should open for international flights from 15 July. Flights in Malawi were put on hold from the 1 May in a bid to contain the spread of the COVID-19 pandemic. Source: BusinessMalawi™
- Mozambique: A total of 1,007 Mozambican companies have asked the National Social Security Institute (INSS) to waive fines and interest charges in the context of COVID-19 impact relief, the minister of Labour and Social Security has said. Margarida Talapa told the daily 'Notícias' that the INSS had granted 366 requests for waivers of fines and interest on arrears, with other companies'

 Nigeria: About 20 operators in the aviation sector, including the Federal Airports Authority of Nigeria, have submitted their operational restart plans to the Nigerian Civil Aviation Authority as the country prepares to reopen its airspace to commercial flights from 21 June 2020. Source: Economic Confidential

- Sudan: The Sudanese government on Wednesday, 17 June decided to extend the full curfew in Khartoum State for 10 more days starting Friday, 19 June to prevent the spread of COVID-19, Security and Defense Council announced. "The Council has approved the recommendations by the Higher Committee for Health Emergencies to extend the curfew from June 19 to June 29," the Council said in a statement. Source: Xinhua
- Rwanda: Rwanda's National carriers, Rwandair has announced a prolonged suspension of commercial flights into the country despite a recent cabinet meeting opening tourism and hospitality activities including holding meetings in hotels. The cabinet on 16 June reopened domestic and international tourism. However, international tourists allowed are only those on charter flights. The airline said that Rwanda's airspace remains closed to commercial flights in order to curb the spread of COVID-19 into the country. Source: KT Press
- Rwanda: The International Monetary Fund (IMF) Board on Thursday, 11 June approved the disbursement of the funds bringing the total to IMF COVID-19 support to Rwanda to USD220.46million. Source: The New Times
- **Tanzania:** In a week that the region's governments were unveiling their annual budget for financial year 2020/21, the World Bank has forecast Tanzania's economic growth to slow down sharply in 2020 to 2.5% from last year's 6.9% as a result of the COVID-19 pandemic and the ensuing global economic crisis. *Source: The EastAfrican*

#### PROTOCOLS FOR PERSONAL CARE SERVICES TO RESUME BUSINESS

Khumbudzo Ntshavhenl, MP, the Minister for Small Business Development, issued a Directions in order to provide protocols to mitigate and manage the COVID -19 outbreak amongst employees and customers in the personal care services industry. In consultation with Cabinet member responsible for health (Minister of Health), these services have been deemed safe to resume, under the specified conditions provided.

These Directions are issued in order to assist categories of services under the Personal Care Service industry that are deemed as safe to resume operations and specify conditions (protocols) under which such services may operate. The permitted services under this Directions may only commence with operations upon ensuring full compliance with the relevant protocols for their services. The categories of services that are deemed safe to resume operations are the following -

- 1. Hairdressing;
- 2. Barbering;
- 3. Nail and toe treatment;
- 4. Facial treatment and make up;
- 5. Body massage; and
- 6. Tattooing and body piercing.

- There has been a surge of cases in Gauteng, which saw more than 9 600 new cases last week.

## **COVID-19 STATISTICS IN SA**



#### **HEALTH DEVELOPMENTS**

- The Western Cape is preparing for the **imminent peak** of the epidemic in that province, says Premier Alan Winde. There have been more than 350 deaths in the province in a week and it has 302 people in ICU and a further 1 299 in hospital. About two-thirds of people admitted to ICU do not survive. However, the Western Cape reflects the rest of the country in terms of a total recovery rate of 53%. (News 24)
- Gauteng Health Department is reporting cluster outbreaks related to the holding of funerals. It
  reported at the weekend that 718 people were currently in hospital receiving treatment. In addition,
  of 21 854 people notified as contacts of confirmed cases, 14 378 had completed the 14-day
  isolation period without any sign of infection.
- The general secretary of the South African Council of Churches, Bishop Malusi
  Mpumlwana, has been chosen to head the ministerial advisory committee on behaviour change,
  appointed by the Minister of Health. He is one of a number of religious leaders serving on this
  body which is intended to improve government's ability to secure popular support for social
  distancing and hygiene measures to contain the epidemic. (Daily Maverick)
- The Daily Maverick carries a feature article by a group of health experts that argues the
  coronavirus epidemic can be contained if government pays closer attention to both the biological
  mode of transmission and social routes of transmission. Read more.
- Health workers in the Eastern Cape and Western Cape are reporting that hospitals are under severe pressure, according to an AFP article. At Livingstone Hospital in Port Elizabeth, a nurse reportedly said they were running out of space and protective equipment was inadequate. In the Western Cape, a health worker at a smaller hospital said they battled to refer patients to ICUs as these were already full and so they had to manage seriously ill patients on oxygen alone.
- Want to know what it's like to be Health Minister Zweli Mkhize right now? A long feature in the Insight section of the Sunday Times carries a first-person description of 24 hours in the life of Dr Mkhize, which typically ends at 2 am or 3 am.

#### SOCIAL AND EDUCATIONAL DEVELOPMENTS

#### **ECONOMIC & BUSINESS DEVELOPMENTS**

- A story in the Sunday Times suggests the extent to which the economic agenda, rather than a public health strategy, is currently directing policy in relation to the COVID19 epidemic in South Africa. It discloses that Tourism Minister Mmamoloka Kubayi-Ngubane advocated strongly within Cabinet for the opening up of the tourism and hospitality industries, arguing that there would be little left of these sectors if recovery were further delayed. She told her colleagues 30% of restaurants had already closed their doors permanently and 550 000 to 600 000 jobs could be lost in the hotel industry if they were not allowed to return to operation immediately.
- The Special Investigating Unit is investigating possible fraud relating to the payment of more than R5m from the Unemployment Insurance Fund relief system to a single beneficiary. The recipient rapidly disbursed this payment to a number of other individuals, raising suspicion of money laundering. The relief fund has nevertheless done a lot of good, providing a lifeline to approximately 3.6 million people. (Sunday Times)
- Zimbabwe's Health Minister Obadiah Moyo has been charged with corruption and abuse of office as a result of a large contract for Covid-19 test kits and PPE with a Dubai supplier. This is the Minister's third charge of abuse of office.
- Liquor stores are reporting record demand since sales resumed a few weeks ago typically
  about double the demand before the lockdown. The major alcohol producer, Distell, said "demand
  completely exceeded our forecasts". One of the top sellers? Sedgewick's Old Brown Sherry! (City
  Press)
- Business Times previewed the "emergency budget" due to be delivered by Finance Minister Tito Mboweni on Wednesday. The expectation is that figures will indicate the extent of the decline in the economy and the size of the budget deficit due to the drop in tax revenue.
- The taxi industry is on strike today in an attempt to force government's hand in paying
  compensation for lost revenue by taxi operators due to regulations which limit the number of
  passengers that taxis may carry and severely erode their income.
- The New African Development Bank has granted South Africa a **loan of R1bn** to cushion the impact of the COVID-19 epidemic. (eNCA)
- The Sunday Times carried an article on the "markup madness" applicable to water tanks since the huge demand had been created in preparation for opening of schools. The government had been paying R28 000 a tank for supply, transport and installation on a platform (to create water pressure) while the general price was in the region of R5 000.
