FROM THE DESK OF THE PRESIDENT 29 JUNE 2020

In the latest letter from the President, Ramaphosa announced that COVID-19 deaths have surpassed the 2000 mark. Among those who have lost their lives are health care workers, consummate professionals who cared for the ill, and were a support and comfort to those in hospital isolated from their families.

He stated that it was a devastating blow that healthcare workers, on the frontline of fighting this pandemic, were among those who were lost to the virus. He calls them the true heroes and heroines of the battle against coronavirus. Ramaphosa called for support and PPE to allow these heroes to continue their Herculean work.

With the support of the Solidarity Fund and donations from many individual South Africans, businesses, foundations and other governments, personal protective equipment has been procured for frontline workers. Where there have been shortages of PPE, hospitals have urgently sought supply to ensure availability. Access to PPE is not the only challenge health care workers face. Across the country clinics and hospitals are facing staff shortages. Ramaphosa reassured that the problem is being attended to.

The stigmatisation of people who have proven positive with coronavirus has become prevalent and the President called on society to put this to an end.

"As a society, we have a collective responsibility to stamp out the stigmatisation of people infected with the coronavirus...Just as we came together to promote acceptance of people living with HIV and stood firm against victimisation, we must show understanding, tolerance, kindness, empathy and compassion for those who are infected with this virus and for their families."


TRACKING THE PANDEMIC

Past Issues

The sharp increase in new COVID-19 cases in **Gauteng** is the most noteworthy feature of the recent coronavirus updates.

Health Minister Zweli Mkhize has commented on it: "We believe that within the coming days, Gauteng will emerge with the highest COVID-19 numbers. Factors contributing to this trend are inward migration, the large population (especially in metros like Johannesburg, Ekurhuleni and Tshwane), increased congregating which spurs cluster outbreaks, and the level to which people are able to adapt to new behaviours such as social distancing and the wearing of masks." (News 24)

The apparent drop in the **mortality rate is misleading** – it is "diluted" by the sudden surge in new cases. Death typically occurs after weeks of illness, not in the first few days.



HEALTH DEVELOPMENTS

Rapport reports that **Eastern Cape hospitals are buckling** under the stress of the epidemic. It quotes a couple of doctors. "We are sitting with a situation where patients are lying in the corridors of hospitals like Livingstone in Port Elizabeth and are dying. Many of them need oxygen, but there is not enough for everyone. So, those without oxygen are fighting those who do have it to try to 'steal' it. Sick people are fighting each other," said one source. A doctor at Dora Nginza Hospital said the maternity unit was overloaded an unable to cope.

Provinces are experiencing **budget pressures in providing facilities** for coronavirus patients. Western Cape Transport and Infrastructure MEC Bonginkosi Madikizela told City Press that the funding issue is alarming because they need to secure more quarantine facilities to ensure that citizens are not left in the lurch. "We had to redirect some of our budget to fight COVID-19 because of our responsibility to ensure that there are enough quarantine sites. The problem is that we do not have the funds to secure the number of beds that [projections say will be required]," he said. Western Cape, with 4 766 beds, has enough capacity for its current demand. Gauteng, with 8 740 beds currently, is rapidly scaling up at seven hospitals to prepare for peak demand in July and August.

SOCIAL & DEVELOPMENT ISSUES

The South African National Taxi Council (Santaco) and the National Taxi Alliance (NTA) say the government is not taking the industry seriously and that they have decided to take the "the bull by its horns" and go back to **loading passengers at 100% capacity** from Monday. Long-distance taxis will also be back in operation, **crossing provincial boundaries** in disregard of regulations. Santaco has threatened to pull all its taxis off the road the minute a law enforcement officer stops one vehicle for breaking lockdown regulations. (News24 and SAfm)

Some journalists continue to be fixated on the **contradictions** in lockdown regulations. For example, News24, observes that the new Level 3 lockdown regulations gazetted allow people to visit friends and family at restaurants, cinemas and casinos, but you are not legally allowed to visit them at home.

RESEARCH & SCIENTIFIC DEVELOPMENTS

The head of the **World Health Organisation continues to caution** that the development of an effective COVID-19 **vaccine is not a foregone conclusion**. Speaking by video-conference to deputies from the

was at an advanced stage of development. (Reuters)

BCC reported at the weekend on a vaccine candidate developed by **Imperial College, London**, entering human trials. This vaccine uses synthetic strands of genetic code, called RNA, which mimic the virus. Once injected into muscle, the **RNA self-amplifies** and instructs the body's own cells to make copies of a spike protein found on the outside of the virus, which should train the immune system to recognise and fight coronavirus. Because miniscule amounts of genetic code are used in the Imperial vaccine, the Imperial College team says **one litre** of its synthetic material will produce **two million doses**.

Reuters reports that **China National Biotec Group** (CNBG) has announced that early human trial results for a coronavirus vaccine candidate suggested it could be safe and effective. The experimental shot has induced **high-level antibodies** in all immunised participants in a Phase 1/2 clinical trial involving 1 120 healthy people, according to preliminary data, CNBG said in a posting on the social media platform WeChat. It did not disclose specific results.

Mark Heywood conducted in-depth interviews with Helen Rees, chairperson of the South African Health Products Regulatory Authority (SAHPRA) and executive director of the Wits Reproductive Health and HIV Institute, and Professor Shabir Madhi, incoming dean of the Faculty of Health Sciences at the University of the Witwatersrand. (Daily Maverick) The focus is **whether politics and wealth will be a barrier to universal and equal access** to this critical vaccine. Here are some quotes:

- Rees: "Vaccines under these circumstances must be described as what's called a 'global public good'. That means that they should be equitably made available to everyone in the world, irrespective of whether you're a big or a small country or a rich or a poor country."
- Madhi (commenting on the fact that the Ox1Cov-19 Vaccine VIDA-trial, a collaborative effort between Wits University and the University of Oxford, is Africa's only clinical vaccine trial for COVID-19): "There's a number of reasons that can influence why vaccines work differentially between different settings. So, if we don't generate evidence right now, we will never know just how well this vaccine will or will not work in our local context."
- Rees: "This cannot be **all for some and none for others**. This has to be an equitable distribution of vaccines."
- Rees: "The reason why there are so many types of vaccines is we are looking at not only having a variety of types to make sure that something works, but also that some types of formulations of vaccines are **much easier to manufacture** than others and can be done really quickly and to scale."
- Rees: "Many pharmaceutical companies are investing a lot and they're doing it at-risk. So, they are investing in the development of the technology in the clinical trials, but they're also looking at investing in manufacturing."
- Madhi, who is confident that a vaccine will be developed: "The coronavirus is much less complex than TB, HIV and malaria. It's much more genetically stable. Just over a short period of time, we're getting good insight in terms of what might be required for a vaccine to be effective."
